TO ALL INTERESTED PERSONS IN THE CITY OF PINCONNING:

PLEASE TAKE NOTICE that the City Council of the City of Pinconning will hold a public hearing on Monday, October 20, 2014 at 6:00 o'clock, p.m., prevailing Eastern Time in the Council Chambers, City of Pinconning, Bay County, Michigan, to consider the adoption of amendment to the Development Plan for the Downtown Development Authority of the City of Pinconning pursuant to Act 197 of the Public Acts of Michigan of 1975, as amended.

The DDA amends its Development Plan by adding the following:

"K. The Downtown Development Authority (hereinafter referred to as the "DDA") will join with local area banks to create a Business Improvement Program (BIP) the intent of which will be to encourage owners of improvements within the Downtown Development District to improve existing buildings and/or the purchase of equipment and/or provide landscaping for businesses whose properties which are within the downtown DDA district. These improvements should preserve the private investment in the area, improve the viability of businesses within the DDA District and improve the overall community's appearance. The BIP encourages the business owner on his own or through his own bank which may be combined with a grant and/or loan through the DDA to pay for the improvements. Improvements are intended to include, but not be limited to improving existing buildings, landscaping, curb appeal, signage, roofs, windows, entrances and updating equipment used in the particular business. The program is to be used for the improvement of existing facilities and not for new buildings."

At the public hearing, all interested persons desiring to address the City Council shall be afforded the opportunity to be heard in regard to the approval of the Plan amendment.
